**MOTIONS OTHER THAN GOVERNMENT MOTIONS**

1. Mr. Nordick (Motion #276)

THAT this House urges the Government of Yukon to continue expanding education and training programs in areas of particular relevance to the North, such as First Nation governance, mining, tourism, resource management, construction north of 60, health care professionals, care providers and teachers.

**GOVERNMENT MOTIONS**

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

## 2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

## 3. Hon. Mr. Hart (Motion #169)

THAT this House urges the Government of Yukon, through the Department of Community Services, to establish an Infrastructure Fund to address the immediate infrastructure needs of Yukon communities.

## 4. Hon. Mr. Cathers (Motion #170)

THAT this House urges the Government of Yukon to utilize the review of social assistance rates currently underway to increase social assistance rates for those in need, and to provide incentives for those on social assistance who want to enter the work force.

## 5. Hon. Mr. Cathers (Motion #194)

THAT this House urges the Government of Yukon and the Yukon Registered Nurses Association to continue working together on the development of legislation that will allow Nurse Practitioners to work within their full scope of practice.

## 6. Hon. Ms. Taylor (Motion #233)

THAT this House urges the Government of Canada to recognize that the unilateral decision in 1966 to integrate the Canadian Forces Superannuation and the Royal Canadian Mounted Police Superannuation with the Canada Pension Plan contributions imposed an injustice and unfairness upon members and retirees of the Canadian Forces and the Royal Canadian Mounted Police, and therefore should take action to remedy that injustice.

## 7. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

## 8. Hon. Mr. Cathers (Motion #357)

THAT this House urges the Department of Health and Social Services to launch a new health promotion initiative to:

- (1) further assist Yukoners who wish to quit smoking by funding a portion of the cost of nicotine replacement therapies; and
- (2) work in partnership with the Motor Vehicles Branch to provide drivers with information on the increased health impacts of smoking within the confined space of a motor vehicle.

**NOTICE PAPER****NOTICES OF MOTION****MOTIONS OTHER THAN GOVERNMENT MOTIONS**

1. Mr. Mitchell (Motion #411)

THAT this House urges the Yukon Government to acknowledge the inappropriateness of the full page advertisements placed in the Yukon News and The Whitehorse Star on April 21, 2008 and that the bill for the advertisements should be paid for by the Yukon Party and not Yukon taxpayers.

2. Mr. Hardy (Motion #412)

THAT this House urges the Yukon Government to study Ontario's proposed Cosmetic Pesticide Ban Act and to work immediately on legislation and regulations that would prohibit the sale and use of pesticides known to be toxic to humans and animals.

3. Mr. Edzerza (Motion #413)

THAT this House urges the Yukon Government to act to reduce greenhouse gas emissions in the transportation sector by purchasing more fuel efficient vehicles for its own fleet, by increasing support for public transit, by encouraging car-pooling and by creating incentives for alternative transport.

THAT this House urges the Yukon Government to ensure that all new Government buildings, at minimum, meet Leadership for Energy and Environmental Design (LEED) standards in the interests of reducing greenhouse gas emissions.
