**GOVERNMENT PRIVATE MEMBERS' BUSINESS**

**MOTIONS OTHER THAN GOVERNMENT MOTIONS**

1. Mr. Nordick (Motion #1008)

THAT this House urges the Government of Yukon to develop a wellness strategy to promote healthy living habits for all Yukoners.

2. Mr. Nordick (Motion #999)

THAT this House urges the Government of Yukon to be fiscally responsible and continue to lay a solid foundation for Yukon growth in all sectors by:

- (1) making strategic investments now in economic, education, health and social capital infrastructure such as schools, hospitals, energy facilities, and transportation and communication infrastructure,
- (2) obtaining maximum benefits from federal funds under Canada's Economic Action Plan that expires on March 31, 2011,
- (3) proceeding with capital projects identified in the multi-year capital plan, which provides strategic direction for the next three years, in order to provide the necessary certainty that will allow the private sector to plan and grow their companies; and
- (4) scheduling major infrastructure projects in Yukon that will match the capacity of local contractors.

## GOVERNMENT MOTIONS

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the Motion #542 Consultation Report done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

6. Hon. Ms. Horne (Motion #832)  
 THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.
7. Hon. Ms. Horne (Motion #935)  
 THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA) process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.
8. Hon. Ms. Taylor (Motion #941)  
 THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.
9. Hon. Ms. Horne (Motion #1007)  
 THAT this House urges the Government of Canada to reinstate its funding for the Aboriginal Healing Foundation to ensure that the Kwanlin Dun First Nation, the Liard Aboriginal Women's Society, the Northern Tutchone Tribal Council, and the Committee on Abuse in Residential Schools Society (CAIRS), which have provided services to residential school survivors, can continue their programs.

**GOVERNMENT MOTIONS**

1. Hon. Ms. Taylor (Motion #1011)

THAT Ray Hayes, Chair of the Yukon Development Corporation Board of Directors, and Dave Morrison, Chief Executive Officer of the Yukon Development Corporation and President and Chief Executive Officer of the Yukon Energy Corporation, appear as witnesses in Committee of the Whole from 3:30 p.m. to 5:30 p.m. on Monday, April 12, 2010, to discuss matters relating to the Yukon Development Corporation and the Yukon Energy Corporation.

**MOTIONS OTHER THAN GOVERNMENT MOTIONS**

1. Mr. Mitchell (Motion #1012)

THAT this House urges the Yukon Government to re-instate a long term substance abuse residential treatment program for those needing continuing assistance with addictions issues after completing the first steps in the stages of recovery, that would:

- (1) assist people in recovery from drug and alcohol abuse to avoid falling back quickly into old patterns of behaviour;
- (2) assist people in recovery to avoid falling under the influence of former friends and associates who are continuing to abuse drugs and alcohol;
- (3) reduce the number of repeat visits to the current 28-day program by people suffering from drug and alcohol abuse;
- (4) assist people in recovery over a longer period of time by creating a 12 month residential treatment program to assist those in need of a longer support period; and
- (5) reduce long term costs incurred by Yukon's health care and justice systems by people faltering in their initial attempts to break their addictive behaviours and suffering long term negative health outcomes or becoming involved with the justice system through criminal behaviour.

2. Mr. Hardy (Motion #1013)

THAT this House urges the Yukon Government to immediately release the feasibility study completed by the Yukon Energy Corporation for a proposed wind farm on Mount Sumanik, north of Whitehorse.

3. Mr. Hardy (Motion #1014)

THAT this House urges the Yukon Government to immediately raise the minimum wage to at least \$10 an hour.
