ORDERS OF THE DAY

GOVERNMENT MOTIONS

1. Hon. Mr. Fentie (Motion #69)

THAT this House urges the Government of Yukon to work collaboratively with the Government of Canada, the Government of the Northwest Territories, the Porcupine Caribou Management Board, all affected First Nations in Yukon and the Northwest Territories, and stakeholders, to develop a Porcupine Caribou Herd Harvest Management Strategy that ensures to the greatest extent possible, the conservation and protection of the Porcupine Caribou Herd.

2. Hon. Mr. Fentie (Motion #167)

THAT this House urges the Government of Yukon, the Government of Canada and Yukon First Nation governments to develop a timely, inclusive process through the re-instated Intergovernmental Forum to implement the recommendations of the Nine Year Review of the Yukon Final Land Claims Agreements in order to ensure the spirit and intent of the land claims agreements are fulfilled.

3. Hon. Mr. Kenyon (Motion #239)

THAT this House urges the Government of Yukon to continue to work with the Government of Canada, First Nations, Yukon College, members of the business community and non-governmental organizations to:

- (1) enhance and develop labour market initiatives targeting First Nations, older workers, youth, persons with disabilities and immigrants through measures such as apprenticeship programs, the Youth Employment Program, the Yukon Nominee Program, the Temporary Foreign Worker Program and other programs,
- (2) develop a national recruiting campaign; and
- (3) assist in the development of retention incentives for employers.

4. Hon. Ms. Horne (Motion #713)

THAT this House urges the Government of Canada and its NATO allies to insist in the strongest possible terms that the Government of Afghanistan fully honour its human rights treaty obligations under international laws and demonstrate its commitment both in law and in practice to respect, protect and enforce the equality rights of the women of Afghanistan or face international sanctions.

5. Hon. Mr. Hart (Motion #723)

THAT this House urges the Government of Yukon to support the findings of the Motion #542 Consultation Report done by the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board, responding to Motion #542 adopted during the 2008 Fall Sitting of the Legislative Assembly, by requesting that the Yukon Workers' Compensation Health and Safety Board and the Employment Standards Board:

- (1) work together within their existing frameworks of authority to appropriately address areas of general consensus;
- (2) work together to ensure adequate training, orientation and supervision of young workers; and
- (3) conduct a review within 5 years to assess the effectiveness of any regulations resulting from this consultation and consider whether there is a need for a general minimum working age in Yukon.

6. Hon. Ms. Horne (Motion #832)

THAT this House urges the Government of Yukon to explore the concept of a multidisciplinary approach to dealing with the complex needs of chronic substance abusers.

7. Hon. Ms. Horne (Motion #935)

THAT this House urges the Government of Canada to meet its obligations under the Yukon First Nation Self-Government Agreements by providing sufficient financial resources to implement these agreements through the Assumption of Responsibilities Agreement (ARA) process; and to demonstrate this commitment by negotiating an appropriate ARA on the administration of justice with the Teslin Tlingit Council.

8. Hon. Ms. Taylor (Motion #941)

THAT this House urges the Government of Canada to work with Canada's tourism industry, provinces and territories and other stakeholders in the development of China Approved Destination Status policies and processes that will enable Canada's tourism sector to capitalize on this opportunity.

9. Hon. Ms. Horne (Motion #1007)

THAT this House urges the Government of Canada to reinstate its funding for the Aboriginal Healing Foundation to ensure that the Kwanlin Dun First Nation, the Liard Aboriginal Women's Society, the Northern Tutchone Tribal Council, and the Committee on Abuse in Residential Schools Society (CAIRS), which have provided services to residential school survivors, can continue their programs.

10. Hon. Mr. Fentie (Motion #1017)

THAT this House urges the Government of Canada to recognize Yukon Self-Governing First Nations as a senior level of government, by working with the first seven Yukon First Nations who settled their land claims to develop new Financial Transfer Agreements that include an

economic development incentive allowing Yukon First Nations to retain an appropriate percentage of their own source revenues.

11. Hon. Ms. Horne (Motion #1241)

THAT this House supports the Government of Canada's introduction of Bill C-54, Protecting Children from Sexual Predators Act, in order to help protect children from adult sexual predators by establishing mandatory prison sentences for seven existing Criminal Code offences such as luring a child, sexual assault and aggravated assault as well as creating two new offences related to facilitating a sexual offence against a child and using telecommunications, including the Internet, to communicate with another person to agree or make arrangements to commit a sexual offence against a child.

12. Hon. Mr. Fentie (Motion #1289)

THAT this House urges the Government of Yukon to ensure that Yukon remains one of the best jurisdictions in the world in which to invest by continuing to implement competitive taxation and royalty regimes in order to maintain or reduce industry's cost of doing business in the territory.

13. Hon. Ms. Horne (Motion #1354)

THAT this House urges the Government of Yukon to consult with the residents of Ross River and the Ross River Dena Council, concerning the replacement of the Ross River Recreation Centre that was recently destroyed by fire.

14. Hon. Mr. Kenyon (Motion#1355)

THAT this House urges the Members of the Official Opposition to either:

- (1) call for debate some of their favourite motions out of the more 1000 Motions Other Than Government Motions, including Motions for the Production of Papers; or
- (2) admit that there was never any intention of actually calling them for debate.

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Mr. Mitchell (Motion #1364)

THAT this House urges the Government of Yukon to work cooperatively with the Board of Governors and the President of Yukon College to investigate the feasibility of establishing a comprehensive dental therapy school at Yukon College to encourage aspiring dental professionals to study and work in Yukon.

2. Mr. Mitchell (Motion #1365)

THAT this House urges the Government of Yukon to reverse its decision to cut funding to rural dental programs after March 31, 2011, and to ensure that all Yukon communities are provided with adequate dental care.

3. Mr. Mitchell (Motion #1366)

THAT this House urges the Government of Yukon to ensure that the Chronic Conditions Support Program receives funding on a permanent basis.

4. Mr. Cardiff (Motion #1367)

THAT it is the opinion of this House that, as the largest financial contributor to Yukon College, the Government of Yukon must:

- (1) evaluate the impact of increased tuition fees on lower- and middle-income Yukoners, which are to rise 20% for the next academic year,
- (2) discuss with Yukon College a process on how it consults with students and faculty on tuition fee increases; and
- (3) explore options regarding the Yukon grant and bursaries that would allow for adult learners who didn't attend a Yukon high school to obtain financial support for post-secondary education.

5. Mr. Cathers (Motion #1368)

THAT this House urges the Select Committee on Whistle-blower Protection to complete its work, and submit a final report to the Legislative Assembly.

6. Mr. Cathers (Motion #1369)

THAT this House urges the Yukon Government to develop Whistle-blower Protection legislation based upon the work of the Select Committee on Whistle-blower Protection once that committee has completed its work and submitted a final report to the Legislative Assembly, and to introduce such legislation to the Legislative Assembly as soon as practicable thereafter.

7. Mr. Cathers (Motion #1370)

THAT this House urges the Official Opposition House Leader to, in the future, avoid calling proposed legislation for debate that is not ready and still needs public consultation.
