ORDERS OF THE DAY

GOVERNMENT MOTIONS

1. Hon. Mr. Dixon (Motion #119)

THAT this House urges the Government of Yukon to develop and implement a Yukon Water Strategy that will help provide long-term direction for economically and environmentally responsible development, management, and use of water in Yukon and establish principles to guide future decision making.

2. Hon. Mr. Cathers (Motion #211)

THAT this House urges the Yukon Government to continue to:

- (1) respect the fact that there are many hundreds of families in Yukon that depend upon mineral exploration in order to make their mortgage payments, feed themselves, and ensure a proper education and a bright future for their children; and
- (2) support responsible mineral exploration and responsible mining as key elements of a strong, diversified Yukon economy.

3. Hon. Mr. Dixon (Motion #212)

THAT this House urges the Government of Yukon to continue to work with industry, First Nations, and non-governmental organizations to:

- (1) attract investment to Yukon; and
- (2) encourage the development of responsible economic projects.

4. Hon. Mr. Kent (Motion #213)

That this House urges the Government of Yukon to work with Yukon College, the Yukon Mine Training Association, and the mining and exploration industries to train and develop a skilled work force made up of Yukon residents to meet the current and future needs of the mining and resource sectors.

5. Hon. Mr. Cathers (Motion #215)

THAT this House urges the Government of Yukon to continue to work with the Yukon Water Board and the Yukon Environmental and Socio-economic Assessment Board to improve Yukon's assessment and regulatory processes.

6. Hon. Mr. Pasloski (Motion #216)

THAT this House urges the Government of Yukon to preserve and maintain the Free Entry System of mineral allocation in Yukon.

7. Hon. Mr. Nixon (Motion #219)

THAT this House urges the Government of Yukon to continue to work with Public Safety Canada and the Royal Canadian Mounted Police to:

- (1) implement the new twenty-year agreement with the Government of Canada for the provision of police services,
- (2) support the RCMP in the provision of a professional, effective and efficient territorial police service that is responsive to the needs of all Yukon communities,
- (3) address street crime; and
- (4) implement the recommendations of the Sharing Common Ground report.

8. Hon. Mr. Dixon (Motion #241)

THAT this House urges the Government of Yukon to implement the 2012 Aishihik Bison Herd Management Plan, which includes allowing a Fall hunt in selected areas, reducing the cost of the seal from fifty dollars to ten dollars, and maintaining hunting as the primary management tool.

9. Hon. Mr. Kent (Motion #242)

THAT this House urges the Government of Yukon to implement initiatives that will enhance the safety of oil-fired appliances, including regulatory and/or legislative changes, public awareness and training initiatives for industry, based on the report of the Oil-Fired Appliance Working Group and input received from Yukon citizens, municipal and First Nation governments, industry and other interested groups during the community tour that took place in September and early October 2012.

NOTICE PAPER

MOTIONS OTHER THAN GOVERNMENT MOTIONS

1. Ms. Moorcroft (Motion #270)

THAT this House urges the Government of Yukon to introduce to this House amendments to implement all of the recommendations for legislation in the Action Plan and Recommendations document of the Oil-Fired Appliances Working Group, including allowing only licenced, qualified oil-burner mechanic journeypersons to install, modify, service or authorize the installation, modification or service of an oil-fired appliance.

2. Ms. Hanson (Motion #271)

THAT it is the opinion of this House that the Government of Canada should:

- (1) meaningfully involve people who live in the North, including Aboriginal peoples, scientists, policy makers and interested members of the public, when determining its agenda for the Arctic Council,
- (2) consider the ideas and recommendations contained in the report Canada as an Arctic Power: Preparing for the Canadian Chairmanship of the Arctic Council; and
- (3) in collaboration with, and on behalf of, people who live in the North, pursue the following issues with the Arctic Council:
 - (a) advocating for increased participation of Aboriginal people from across the circumpolar north in the Arctic Council,
 - (b) promoting discussion of whether others with interests in the Arctic, including emerging economic superpowers like Brazil, India and China, and groups like the International Maritime Organization, should participate in the Council,
 - (c) developing plans to improve the socio-economic, physical and mental health of people throughout the circumpolar north; and
 - (d) co-operative planning for emergency management, oil spill response, critical infrastructure resilience, and collective enforcement of regulations for new or expanded Arctic industries, such as commercial fisheries.

2. Mr. Elias (Motion #272)

THAT this House supports the Minister of Community Services in her pan-northern efforts to ensure that a successor funding program to the Building Canada Fund is established and that the new fund continues to address national, regional and local infrastructure priorities and supports projects designed to deliver results in three areas of national importance:

- (1) a stronger economy,
- (2) a cleaner environment; and
- (3) strong and prosperous communities.

3. Mr. Silver (Motion #273)

That this House urges the Government of Yukon to develop an Individual Learning Centre in Dawson City, as requested by the Tr'ondek Hwech'in First Nation, in order to address students who are struggling at Robert Service School.
