WRITTEN QUESTIONS

1. Written Question No. 6 (November 27, 2019)

Mr. Kent, Member for Copperbelt South

Addressed to the Hon. Mr. Pillai, Minister of Energy, Mines and Resources

With respect to compensation for individuals whose placer and quartz mining claims are negatively affected by government decisions, can the minister:

- (1) provide further detail on the government's plan on using compensation as a tool to negotiate with placer and quartz claim holders;
- (2) provide the details of its plan to address current and future expropriation of placer and quartz mining claims in the territory, including:
 - (a) what tools will be used to ensure that all parties are treated fairly in the negotiation process; and
 - (b) what the projected costs will be and who will cover them in regard to:
 - i. negotiations;
 - ii. compensation; and
 - iii. administrative and legal fees;
- (3) provide updates on current negotiations with placer claim holders within the municipality of Dawson City who have been negatively affected by government decisions; and
- (4) provide updates on any expropriations that may have occurred since January 1, 2017?

2. Written Question No. 7 (November 27, 2019)

Mr. Kent, Member for Copperbelt South

Addressed to the Hon. Mr. Pillai, Minister of Energy, Mines and Resources

With regard to the Yukon Resource Gateway announced by the Government of Yukon and the Government of Canada on September 2, 2017, can the minister provide:

- (1) confirmation on how much of the \$468,845,000 has been spent to date;
- (2) a breakdown of where that money has been spent; and
- (3) timelines for the remainder to be spent, broken down by:
 - (a) road;
 - (b) project; and
 - (c) type of work?

3. Written Question No. 10 (November 27, 2019)

Mr. Kent, Member for Copperbelt South

Addressed to the Hon. Mr. Pillai, Minister of Energy, Mines and Resources

With regard to the land withdrawals and staking bans within Yukon, could the minister provide a table listing all current land withdrawals and staking bans that includes the following information:

- (1) name or title of the land withdrawal or staking ban;
- (2) location of the land withdrawal or staking ban;
- (3) total area of the land withdrawal or staking ban;
- (4) expiry date of the land withdrawal or staking ban; and
- (5) date of initial withdrawal and all subsequent renewals?

Government Motions

1. Motion No. 212

Hon. Mr. Streicker, Minister of Community Services

THAT a Special Committee on Civil Emergency Legislation be established;

THAT the Hon. John Streicker be appointed to the committee;

THAT the membership of the committee also be comprised of one member from the Official Opposition caucus selected by the Leader of the Official Opposition, and one member from the Third Party caucus selected by the Leader of the Third Party;

THAT the Leader of the Official Opposition and the Leader of the Third Party inform the Clerk of the Legislative Assembly of the names of the selected members from their respective caucuses no later than seven calendar days after the adoption of this motion by the Assembly;

THAT the Chair of the committee have a deliberative vote on all matters before the committee;

THAT the committee:

- (1) consider and identify options for modernizing the *Civil Emergency Measures Act*; and
- (2) make recommendations on possible amendments to the *Civil Emergency Measures Act*;

THAT the committee be empowered to conduct public hearings for the purpose of receiving the views and opinions of Yukoners;

THAT the committee have the power to call for persons, papers, and records and to sit during intersessional periods;

THAT the committee report to the Legislative Assembly on its findings and its recommendations by August 31, 2021;

THAT, if the House is not sitting at such time as the committee is prepared to present its report, the Chair of the committee shall transmit the committee's report to the Speaker, who shall transmit the report to all Members of the Legislative Assembly and then, not more than one day later, release the report to the public; and

THAT the Clerk of the Legislative Assembly shall be responsible for providing the necessary support services to the committee.

1. Motion Respecting Committee Reports No. 1

Mr. Adel, Chair, Standing Committee on Appointments to Major Government Boards and Committees

THAT the Standing Committee on Appointments to Major Government Boards and Committees' 21st report, presented to the House on October 1, 2020, be concurred in; and

THAT the amendments to Standing Order 45(3.2)(a) recommended by the committee, adding to the list of entities for which the committee reviews nominations and recommends appointments, the Yukon Human Rights Panel of Adjudicators, be adopted.

THAT this House congratulates the Yukon T1D support network for their efforts in convincing the government to recognize the importance of and securing coverage for continuous glucose monitors for all Yukoners living with type 1 diabetes.

2. Motion No. 217

Mr. Cathers, Member for Lake Laberge

THAT this House urges the Yukon government to seek an agreement with the City of Whitehorse that allows commercial waste haulers to resume providing this important waste hauling service to farms, businesses, and residential customers outside of city limits at rates that are affordable and predictable.

3. Motion No. 218

THAT this House urges the Government of Yukon to work with the Government of Canada, Champagne and Aishihik First Nations, Kluane First Nation, local communities, chambers of commerce, businesses, organizations, and community members to increase access to the front ranges of Kluane National Park and Reserve of Canada along the Haines Road and the Alaska Highway for the purpose of creating more land- and air-based tourism and business opportunities.

THAT this House urges the Yukon government to work with First Nations, the Yukon Fish and Wildlife Management Board, renewable resources councils, the Yukon Fish and Game Association, the Yukon Trappers Association, the Yukon Outfitters Association, and individual hunters, trappers, and anglers to improve the management of fish and wildlife populations so as to ensure that healthy populations will sustain hunting and fishing opportunities.

5. Motion No. 220

THAT this House urges the Government of Yukon to use its 2020-21 budget to build a school in Burwash Landing.

6. Motion No. 221

Ms. White, Leader of the Third Party

THAT this House urges the Government of Yukon to explain why it is relaxing enforcement of Yukon's COVID-19 self-isolation requirements at Yukon's land borders at the same time as other Canadian jurisdictions are experiencing a second wave of the COVID-19 pandemic.
